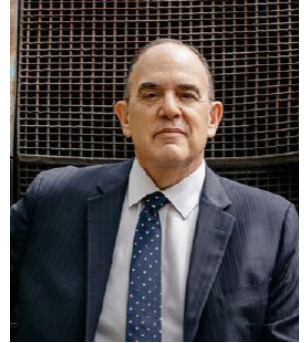
## NEUTRAL BIO
